Eligibility	Graduation under 10+2+3 with Urdu as one of the subject at 10 th /12 th level and having secured at least 40% marks. However, 50% seats shall be reserved for the candidates having graduated with Urdu as one of the Subject.
Mode of Selection	On the basis of merit at qualifying Examination
Intake Capacity	Thirty seats (30 seats)
Fee Structure:	Rs. Six thousand only.

Statutes as in vogue for other P.G Diploma courses shall be applicable to the course/programme.
