2. All qualification certificates in original alongwith self-attested Xerox copies for verification.


The engagement shall be purely an academic arrangement and the engagee shall not be entitled to any appointment/service benefit on account of this order.


The wages of above Contractual Lecturer shall be paid by debit to the "Local Fund" of the Directorate of Distance Education.
