- That the engagement shall come to an end by the end of the academic session 2025 or till the post(s) is/are/ filled on permanent basis or as and when the University declares winter holidays whichever is earlier;
- That the engagement shall be purely based on performance/conduct behavior to be monitored evaluated by the concerned Head of the Department periodically.

- Joining report to be submitted through Head/Director/Coordinator of the concerned Department;




