**WHEREAS**, upon promulgation of the Jammu & Kashmir Reorganization Act, 2019 (34 of 2019), the UT of Jammu & Kashmir (J&K) and Ladakh came under the purview of NCTE.

**2. AND WHEREAS**, NCTE vide Public Notice invited applications from the existing institutions in the UT of Jammu & Kashmir (J&K) and Ladakh during 1st July to 31st August 2020 followed by another Public Notice inviting applications during 11th December 2020 to 7th February 2021, from those institutions which could not apply earlier.

**3. NOW WHEREAS**, in terms of Section 14 (1) of the NCTE Act, 1993, University Of Kashmir, Naseembagh, Naseembagh, [Hazratbal, Srinagar, Srinagar, Jammu And Kashmir-190006](#) has applied for Grant of Recognition to Directorate Of Distance Education, University Of Kashmir, Hazratbal, Naseembagh Hazratbal, [Hazratbal, Srinagar, Srinagar, Jammu And Kashmir-190006](#) for online on 27/08/2020, in Northern Regional Committee.

**4. AND WHEREAS**, on scrutiny of the application, the documents attached therewith, the affidavit submitted and the inspection report received from Visiting Team and compliance report of Letter of Intent submitted by the institution, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said Teacher Education Programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the said programme.

**5. NOW THEREFORE**, in exercise of the powers vested under Section 14 (3)(a) of the of the NCTE Act, 1993, the Northern Regional Committee, NCTE in its **431 (Volume-1) meeting held on 09/12/2024** hereby grants recognition to Directorate Of Distance Education, University Of Kashmir, Hazratbal, Naseembagh Hazratbal, [Hazratbal, Srinagar, Srinagar, Jammu And Kashmir-190006](#), under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 as amended from time to time for conducting the following courses under ITEP:-

6. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
7. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
8. The institution shall submit to the Regional Committee a Performance-Appraisal Report (PAR) at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
9. The institution shall maintain its own website with hyperlink to the NCTE website uploading the required information / documents as per clause 7(14) of the NCTE Regulations 2014 as amended time to time.
10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
11. If the Institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations, and orders made of issued there under, the action including withdrawal of recognition shall be taken by the Regional Committee under the provisions of Section17(1) of the NCTE Act.
