#### **GUIDELINES FOR ONLINE EXAMINATION**

(For B Sc Nuring (3<sup>rd</sup> Year Regular / Supplementary / Backlog) offered through College of Nursing GMC), Bibi Haleema College of Nursing, Srinagar and Nursing College Bhagh- i-Dilawar Khan Srinagar

In view of COVID-19 outbreak and implementing the Standard Operating Procedures (SOP's) issued by Ministry of Human Resource Development (MHRD), Govt. of India vide No.F16-16/2020-UIA, dated 6th July 2020, and UGC guidelines for conducting examinations dated 29/04/2020 and revised guidelines titled "UGC Revised Guidelines on Examinations and Academic Calendar for Universities in view of COVID-19 Pandemic", dated 6th July 2020, the University of Kashmir in adherence to these guidelines framed the comprehensive guideline titled "Mode and Method of Examination, Guideline-2020" wherein all the departments of university are entrusted to conduct the external examinations in general and terminal/end semester examinations in particular in order to save the carrier of thousands of students. After threadbare discussion, the Departmental Committee of Directorate of Distance Education at its meeting held on 8th June, 2020, unanimously decided to conduct the pending and due examination of MA/ M. Sc. / M. Com, / PG Diplomas/ Diploma/ Certificate Courses / backlog/ mercy chance/ division improvement candidates through online mode in adherence to the SOP's issued from time to time.

Keeping in view the successful conduct of various online examinations by the Directorate of Distance Education, the Controller of Examination University of Kashmir has requested this Directorate to conduct the examination of B Sc Nuring (3<sup>rd</sup> Year) offered through College of Nursing GMC), Bibi Haleema College of Nursing, Srinager and Nursing College Bhagh-i-Dilawar Khan Srinagar. The sole aim is to save the future of concerned students in these testing times. Therefore, this Directorate shall conduct the examination of said candidates of B Sc Nursing (3<sup>rd</sup> Year) through ONLINE mode, and date sheet to this effect stands already issued.
