


**AFFIDAVIT**



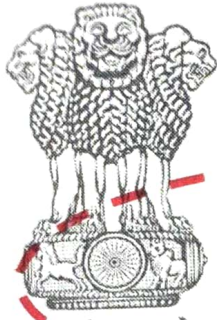

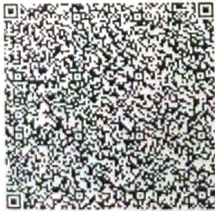
