 - a) The engagee(s) shall not claim continuation for next academic session of 2026;
 - b) The engagee(s) shall not claim absorption/permanence or regularization against the said engagement;
 - c) The engagee(s) shall abide the directions of the University authorities and maintain discipline in the University;
 - d) The engagee(s) shall pave as and when the regularly selected candidate is appointed against the post or by transfer as the case may be, if they are engaged against duly sanctioned post;
 - e) That the Certificates and other testimonials submitted by the engages are genuine and not fabricated and in case, it is found, at any stage of their engagement in the University, that the certificate/s or any other record/s submitted by him/her is not based on facts or has been misrepresented the contract shall get invalidated leading to their termination from the temporary engagement. Besides, the university reserves a right to take any other action as may be deemed appropriate against him/her;
 - f) The engagee(s) should submit the undertaking, if they are satisfied with the terms conditions mentioned in the advertisement notice/engagement order.
