The regularisation of their services is subject to the following conditions :-


- The cases of the illiterate employees will be referred to the Committee constituted for the purpose of determination of their age. In case the committee determines their age more than the minimum / maximum age limits at the time of their initial appointment they will cease to be employees of the University and their services would stand automatically terminated from 1/4/2001.

2. They will submit the following documents in original within 15 days for verification :-

- a) Date of Birth certificate from the Head Master concerned to be authenticated by the Director, School Education/Board of School Education. Any mutilation or tampering detected in the certificates will tantamount to loss of appointment of the concerned;
- b) State subject certificate;

3. All these employees shall be paid their wages on daily wage basis, pending release of funds by the State Government on this account in the shape of additional grant.
