The Dean, School of Open Learning forwarded the minutes of the CIQA sub Committee with regard B.Ed PPR for batch-2024 with the request to approve the recommendations of the CIQA sub Committee in anticipation of the Academic Council.

The CIQA sub Committee at its meeting held on 22-10-2024 while considering the PPR of B.Ed for batch 2024, recommended the following:-

“the B.Ed Statutes for the Distance Mode, which were approved by the earlier University Council, have been published in the University Gazette/Calendar. The current Programme Project Report (PPR) has been developed in accordance with the UGC-DEB (University Grants Commission-Distance Education Bureau) guidelines, fulfilling all Statutory requirements. The PPR has been thoroughly vetted and is to be placed before the Academic Council for approval”.

The above recommendations were approved by the Vice-Chancellor in anticipation of the approval of the Academic Council, as the same is the prerequisite for the recognition of B.Ed Programme.
