

Item: - To review the Self Learning Material of B.Ed. Batch-2024.


Resolution:- The CIQA Sub Committee conducted a comprehensive review of study material of the B.ED programme. The review was conducted on the following parameters:


- Language and Presentation

- Review and Evaluation



The meeting ended with a vote of thanks to the chair.




