Subject: Issues related to validity of degrees in teacher education obtained from the State of J&K.

Sir,

The NCTE Act, 1993 extends to the whole of India except the State of J&K. The issue of validity of degrees in teacher education obtained from the State of Jammu & Kashmir has been attracting the attention of NCTE and MHRD for quite some time past. Now the MHRD has given the following clarifications:

a) *Persons who have obtained degrees from institutions recognized by the Govt. of J&K/UGC would be eligible for employment in Central Govt. and other States; and*

b) *As the NCTE Act does not cover the issue of admission in institutions for higher qualifications, the eligibility of persons with degrees from institutions in J&K will not be governed by the provisions of the NCTE Act but by the relevant laws/rules/regulations of the respective States/Universities.*

3. The above clarifications are for your information and necessary action.

Hlo I want to post a grievance regarding unjust act of Kashmir University (Directorate of Distance Department). I am a student of the said department currently pursuing B.Ed (4th semester), batch 2022 and I had appeared for all the papers of previous year but my result was showing N.A. in a written paper and failed in Viva. I went to University for re-checking and I came to know that my said written paper was clear having good marks and this was all the carelessness of the university but my viva is still showing (F). During my first visit, the officials said that the award roll has been misplaced and after that I went to distance department umpteen times I want to mention here that a single visit to the university from my place costs me Rs. 150. First of all it is a matter of fortune that one will find all the officials of the department present there as I have mostly found the doors locked secondly they are habitual of showing rude behaviour even with the female students despite being guilty as one of the official said to me "I can't do anything, you should forget about your one year" Is it humane?? and the another one is playing smart by asking the stupid questions to me as "What was the name of the examiner", In which hall viva was held", What was the time". Sir/Mam I am not a regular student, I visit University after months how can one remember the hall number as there are 3 stories in the distance department. Is this the duty of a student to remember the full bio-data of the examiner?? According to them I have to pay the examination fee again in which I have already appeared and the award has been misplaced by their carelessness. Neither I can afford fee again and nor I have too much to spend on fare as I have payed umpteen visits to department but of no use as they are too much rude. Now, I want your good self kindly look into the matter as they are often showing carelessness in their work and then they are habitual of showing rude behaviour. This is totally injustice and even oppression as they want me to wander to one by one of them and beg them for their mistake this should dis-continue. I am really so much bothered by all this from months, it was my bad-luck that I enrolled in their department. They forced me to come here and post as I have not done anything wrong in it the award rolls have been misplaced by their carelessness as they are habitual of it and they are showing anger to me, despite being wrong. Kindly help so that I can complete my program and get my degree with in due course of time. One more request is that kindly don't dismiss my complaint without proper justice. 

I received a response regarding my submitted grievance under reference number 999004837524, but I find the information provided unsatisfactory. It was stated that no grievance was submitted by the candidate prior to the final result declaration. However, it's important for the university authorities to recognize that some serious issues/situation can arise unexpectedly in life, causing individuals to overlook certain matters and unfortunately, it must be acknowledged that not all candidates are able to afford smartphones. From my perspective, everything was in order, and I was unaware that my college failed to submit my assessment. After the final result declaration, I managed to visit the DDE office in March 2022 where I was informed that I had missed my internal assessment test and that no grievances could be addressed at that point. I was instructed to reappear with the batch of 2018 and was told to await further notification. Subsequently, in September 2021, notification for the 2018 assessment test for batch 2018 was released, scheduled to be conducted online. I visited the DDE office on September 27, 2021, where I was advised to submit an application to the Director of DDE (a copy of which is attached) requesting permission to retake the test, along with providing a reason for the request. I complied with this request and my internal assessment test was conducted offline at the DDE office on the same date. I was assured that the results would be declared via notification. However, the final results for the 2018 batch were announced on April 8, 2022, yet my results still showed as nil. Upon recontacting the DDE office, I was directed to contact my college regarding the matter. Upon doing so, I come to know that my assessment copy had not been submitted due to a technical error. They provided me with a copy of the assessment test (13 months after the result declaration, as mentioned in the previous response) to submit to the DDE office, which I promptly did. Now I have a few straightforward inquiries: • When I visited the DDE office on September 27, 2021, why was I requested to submit an application, and why was an internal assessment test conducted? • When the college provided me with the original assessment copy, why did the DDE office accept the awards? If they had informed me that they do not handle post-result grievances, I would have reappeared for the entire semester. Now, three years after the declaration of the results, it appears that I have no option but to seek assistance from the court. Currently employed in the private sector, I am unable to leave my job and reappear for the entire semester as I have a family to support. I am respectfully requesting the authorities and the Director of DDE to please examine the matter and provide me with a final satisfactory resolution.

The desired information is as follows:

1. The Candidate claims that he was told by the office of CDOE to submit the application which is baseless. The candidate submitted the application for redressal of his grievance on his own which was not maintainable after 13 months declaration of final results.
2. Candidate further claims that he has been told by the Office to appear in offline exams which is false information provided by the candidate. Office of the CDOE has not issued any notification for the same. Pertinent to mention that the office of the CDOE is always uploading each and every notification on CDOE official website, while checking any such notification on website it was found zero result which shows that the candidate is misleading the office by providing false information.
3. Candidate is mentioning two contradictory statements in his representation Viz:
 - a) That I appeared in Internal Assessment test offline in CDOE office.
 - b) That I sought the Internal Assessment awards from the concern College which I submitted to the office of the CDOE.

If the Candidate has appeared in Internal Assessment test in CDOE office then why he sought the internal awards from the concerned college. These two contradictory statements clearly reveals that candidate is trying to mislead the office which disturbs the office routine work and consequently leads to wastage of time.
