1. Date of Birth Certificate;
2. Qualification Certificate;
3. State Subject Certificate;
4. Medical Fitness Certificate;
5. Certificate from the concerned authorities to the effect that no loan under self-employment scheme has been taken by the appointee.

ii. These services shall be initially on probation for a period of two years. If on verification, any of the certificates proves to be fake or forged, the services of such a person shall be terminated ab-initio.

iii. These services shall be governed under the "New Pension Scheme" as applicable to the employees appointed on or after 01.01.2010.

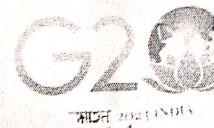
