 - e. Certificate from the concerned authorities to the effect that no loan under self-employment scheme has been taken by the appointee;
 - f. Their services shall be governed under the 'New Pension Scheme' as applicable to the employees appointed on or after 01.01.2010.
- IV. The seniority shall be decided after the Age Committee determines the age of illiterate employees.
- V. They shall submit their joining report in the General Administration.
